AN ACT to amend the Customs and Excise Duties Act, Chapter 48 of the Substantive Laws of Belize, Revised Edition 2011; to provide for the removal of revenue replacement duty on CARICOM goods; to increase the scope of goods subject to excise duty; and to provide for matters connected therewith or incidental thereto.

BE IT ENACTED, by and with the advice and consent of the House of Representatives and the Senate of Belize and by the authority of the same, as follows:-

1. This Act may be cited as the

and shall be read and construed as one with the Customs and Excise Duties Act which as amended, is hereinafter referred to as the principal Act.

section 21.

2. Section 21 of the principal Act is hereby repealed and replaced with the following:

“Excise duty.

21. (1) There shall be levied, charged and collected, such excise duties on the goods as set out in the Second Schedule to this Act.

(2) The excise duties levied under this section shall be payable on goods produced locally or imported into Belize.

(3) Notwithstanding the provisions of section 20 of this Act, the Minister of Finance may when he deems it necessary or expedient to do so, by Order which shall take effect from the date of its publication in the *Gazette*, reduce or abolish any excise duties set out in the Second Schedule to this Act, or restore any such duty to its original level as it were before such reduction or abolition.

(4) Every Order made under this section shall be subject to the provisions of subsections (7), (8) and (9) of section 20 of this Act and shall be read and construed with such necessary modifications and adaptations.”

3. Section 25 of the principal Act is hereby repealed and replaced with the following:

“Revenue
replacement
duty.

25. (1) Subject to subsection (2) below, where any customs duty or entry tax chargeable in respect of goods of a class or description imported into Belize has been removed, altered, reduced or progressively phased down, the Minister of Finance may by Order, impose a revenue replacement duty on such goods or on goods of any other class or description imported from any country.

(2) Goods imported into Belize from a Member State of CARICOM shall not be subject to revenue replacement duty.

(3) The duty payable under this section shall be imposed without any discrimination on goods of the same type, class or description.

(4) The Minister of Finance may by Order increase, reduce or revoke the duty imposed under this section.

(5) Where an Order is submitted to the National Assembly for resolution under section 28 of this Act, the duty payable immediately prior to the making of such Order under this section shall continue to be payable, until publication of the resolution in the *Gazette* under section 28, when the resolution shall take effect in place of the said Order.

(6) Where a refund of duty is paid during the intervening period above, such refund shall be made in accordance with rules made under this Part.”

4. The Second Schedule to the principal Act is hereby repealed and replaced with the Second Schedule as set out in the schedule to this Act.

5. This Act shall come into force on the 1st day of April 2016.
