AN ACT to appropriate certain sums of money for the use of the Public Service of Belize for the financial year ending March 31, 2016.

(Gazetted 1<sup>st</sup> April, 2015)

BE IT ENACTED, by and with the advice and consent of the House of Representatives and the Senate of Belize and by the authority of the same, as follows:-

1. This Act may be cited as the

### <u>GENERAL REVENUE APPROPRIATION</u> (2015/2016) ACT, 2015.

Appropriation of sums of money in the Schedule. 2. The several sums of money appearing in the Schedule hereto are hereby declared to be payable for the financial year ending on the thirty first day of March, two thousand and sixteen, in respect of the services mentioned in the Schedule and shall be charged on the revenue for the year and other funds of Belize.

# Expenditure authorized.

3. Any sum not exceeding the amount set down under each Head in the Schedule hereto may be issued and spent in respect of the establishment of service specified or referred to therein.
