AN ACT to amend the Immigration Act, Chapter 156 of the Substantive Laws of Belize, Revised Edition 2011; to provide, as a companion measure to amendments to the Belizean Nationality Act, Chapter 161, and the Passports Act, Chapter 164, for the bifurcation of functions related to immigration and nationality services, to regularize the use of the term used to describe the head of the government department responsible for immigration; and to provide for matters connected therewith or incidental thereto.
