Considering that the Minister of Works has been engaged in numerous infrastructure projects which are supposed to meet international standards, improve mobility, be climate resilient, improve road traffic safety and meet the demand being created by increasing traffic; And also considering the fact that traffic fatalities involving pedestrians is a significant cause of death in Belize; Will the Minister of Works please inform the nation and in particular the residents who live in the numerous villages along the George Price Highway between Roaring Creek Village and the Santa Elena Roundabout, and specifically in reference to the \$20.5 million contract issued to rehabilitate the 15. 3 kilometers of highway from Roaring Creek to Blackman Eddie and the recently signed \$19 million contract for the rehabilitation of 16.5 kilometers from Blackman Eddie to the Santa Elena Roundabout, whether any consideration was given to the building of pedestrian walkways parallel to the highway in the villages and, if they have been considered, how much if anything has been budgeted for these pedestrian walkways, and, if not, why not?
