## 1. Social Security (Amendment) Bill, 2019.

Bill for an Act to amend the Social Security Act, Chapter 44 of the Substantive Laws of Belize, Revised Edition 2011; to remove offences in relation to insurance stamp; and to provide for matters connected therewith or incidental thereto.

### 2. <u>Income and Business Tax (Amendment) Bill, 2019.</u>

Bill for an Act to amend the Income and Business Tax Act, Chapter 55 of the Laws of Belize, Revised Edition 2011; to provide for taxation of foreign-source receipts under the business tax; and to provide for matters connected therewith or incidental thereto.

#### 3. Free Zones (Amendment) Bill, 2019.

Bill for an Act to amend the Free Zones Act, Chapter 278 of the Substantive Laws of Belize, Revised Edition 2011; to remove the requirement for a permit for certain services to operate within the free zone; and to provide for matters connected therewith or incidental thereto.

### 4. Fiscal Incentives (Amendment) Bill, 2019.

Bill for an Act to amend the Fiscal Incentives Act, Chapter 54 of the Substantive Laws of Belize, Revised Edition 2011; to remove the prohibition on declaration as an approved enterprise if that enterprise has products destined for the domestic or CARICOM market; and to provide for matters connected therewith or incidental thereto.
