### **MOTION**

**1. Establishment of the National Assembly Staff Committee Motion, 2021.**

**WHEREAS**, section 3 (1) of the National Assembly Staff Act Chapter 14 of the Substantive Laws of Belize, Revised Edition 2011; establishes a National Assembly Staff Committee consisting of the Speaker of the House of Representatives, or in his/her absence the Deputy Speaker; three members of the House of Representatives; the President of the Senate and one other member of the Senate nominated by the Senate; and one member of the staff of the National Assembly or one other person who is not a member of staff of the National Assembly, nominated by the staff of the National Assembly;

**AND WHEREAS**, section 3 (1) (c) of the National Assembly Staff Act, Chapter 14 of the Substantive Laws of Belize, Revised Edition 2011; provides that the President of the Senate and one other member of the Senate nominated by the Senate, shall form part of the National Assembly Staff Committee;

**NOW, THEREFORE, BE IT RESOLVED** that this Senate nominate Senator the **Honourable Erica Jang**, to be a member of the National Assembly Staff Committee.
