#### Notice given on 3<sup>rd</sup> February 2021.

**WHEREAS**, it is expedient to amend the Standing Orders of the House of Representatives to allow for the House to meet virtually in the interest of public health, public safety, national security or public emergency, and to establish a Joint Public Accounts Committee, comprising of Members who support the government, Members who do not support the government and Senators;

**NOW, THEREFORE, BE IT RESOLVED** that this Honourable House approves the amendment to the Standing Orders proposed in the draft Statutory Instrument annexed hereto, which is tabled as Sessional Paper No. HR5A/1/13, and the Standing Orders of the House shall be and are hereby amended accordingly.

#### 2. Establishment of the National Assembly Staff Committee Motion, 2021.

#### Notice given on 3<sup>rd</sup> February 2021.

WHEREAS, section 3 (1) of the National Assembly Staff Act, Chapter 14, Substantive Laws of Belize, Revised Edition 2011, establishes a National Assembly Staff Committee consisting of the Speaker of the House of Representatives, or in his absence the Deputy Speaker; three Members of the House of Representatives; the President of the Senate and one other Member of the Senate nominated by the Senate; and one Member of the staff of the National Assembly, nominated by the staff of the National Assembly;
