**MOTION**

- 1. **Resolution to amend the Schedule to the Governor-General (Conditions of Service) Act, Chapter 7 of the Substantive Laws of Belize, Revised Edition 2011, Motion, 2021.**

**WHEREAS**, section 3(2) of the Governor-General (Conditions of Service) Act provides that the House of Representatives may, by resolution, amend the Schedule increasing the salary and duty allowance of the Governor-General;

**AND WHEREAS**, the salary of the Governor-General currently stands at the rate of \$52,848.00 per annum and the duty allowance stands at the rate of \$2,400.00 per annum;

**AND WHEREAS**, the salary and duty allowance of the Governor-General has not been increased since the entry into force of the Act on 5<sup>th</sup> July 1989;

**NOW, THEREFORE, BE IT RESOLVED** that this Honourable House amends the Schedule to increase the salary of the Governor-General to \$75,000.00 per annum and the duty allowance to \$12,000.00 per annum.
