## 1. Securities Industry Bill, 2021.

Bill for an Act to provide for the regulation of securities business and activities and to provide for matters connected therewith or incidental thereto.

#### 2. Stamp Duties (Amendment) (No.2) Bill, 2021.

#### I BILLS FOR SECOND READING

#### 1. <u>Companies (Amendment) Bill, 2021.</u>

Bill for an Act to amend the Companies Act, Chapter 250 of the Substantive Laws of Belize, Revised Edition 2011; to remove the fee for certifying documents as in compliance with the Act; to allow for certain fees to be prescribed by Order published in the Gazette; and to provide for matters connected therewith or incidental thereto.

#### 2. Stamp Duties (Amendment) Bill, 2021.

Bill for an Act to amend the Stamp Duties Act Chapter 64 of the Substantive Laws of Belize, Revised Edition 2011; to exempt certain documents of a company from the payment of stamp duties; and to provide for matters connected therewith or incidental thereto.

### 3. <u>Electronic Transfer of Funds Crimes Bill, 2021.</u>

Bill for an Act to provide the regulation of the transfer of money through electronic means; and to provide for matters connected therewith or incidental thereto.

## 4. Electronic Transactions Bill, 2021.

Bill for an Act to give legal effect to all electronic documents, records and signatures; to repeal the Electronic Transactions Act, Chapter 229:03 of the Substantive Laws of Belize, Revised Edition 2011; and to provide for matters connected therewith or incidental thereto.

# 5. <u>Tax Administration and Procedure (Amendment) Bill, 2021.</u>

Bill for an Act to amend the Tax Administration and Procedure Act, Act No. 8 of 2019; to authorize the Director General to publish the names of tax defaulters in the Gazette and any local newspaper; to amend the general provisions of Part X Criminal Proceedings pertaining to the prosecution of tax offences; and to provide for matters connected therewith or incidental thereto.

# 6. <u>Immigration (Amendment) Bill, 2021.</u>

Bill for an Act to amend the Immigration Act Chapter 156 of the Substantive Laws of Belize, Revised Edition 2011; to provide for the addition of a new category of visitor permit to allow visitors to work remotely from Belize; and to provide for matters connected therewith or incidental thereto.
