AN ACT to amend the Customs Regulation Act, Chapter 49 of the Substantive Laws of Belize, Revised Edition 2020; to provide for measures to ensure compliance with the Financial Action Task Force Recommendations in relation to laws regarding anti-money laundering, combatting the financing of terrorism and combatting proliferation financing; to provide for the requirement to keep records; to provide for forfeiture of undeclared currency; and to provide for matters connected therewith or incidental thereto.

BE IT ENACTED, by and with the advice and consent of the House of Representatives and Senate of Belize and by the authority of the same, as follows:
