**STATUTORY INSTRUMENT**

**No. 121 of 2023**

*ORDER made by the Minister of Finance in exercise of the powers conferred upon him by section 68 (9) (f) of the Money Laundering and Terrorism (Prevention) Act , CAP. 104 of the Substantive Laws of Belize, Revised Edition 2020, and all other powers thereunto him enabling.*

**WHEREAS**, section 68(9)(f) of the Money Laundering and Terrorism (Prevention) Act, CAP. 104, of the Substantive Laws of Belize, Revised Edition 2020 as amended by Act by No. 28 of 2023, provides that where an Order of the Court is made under sub-section 68(9)(a) declaring that a person, or entity listed in Part 1, 2, 3 or 4 of Schedule VIII of the Money Laundering and Terrorism (Prevention) Act is not a listed person , the Minister shall by Order published in the Gazette, amend Schedule VIII accordingly;
