2. Application fee for a Temporary Passport	\$100.00
3. Application for a passport in case of Medical Emergency (in addition to the fee applicable for service listed as items 1 and 2 above)–	\$100.00
4. Application for a passport where previous passport is lost, damaged or stolen (in addition to the fee applicable for service listed as items 1, 2 and 3 above)–	\$200.00
5. Application for a passport for expedition within 24 hours (in addition to the fee applicable for service listed as items 1, 2 and 3 above)–	\$300.00".
