### 1. Belizean Nationality (Amendment) Bill, 2023.

Bill for an Act to amend the Belizean Nationality Act, Chapter 161 of the Substantive Laws of Belize, Revised Edition 2020; to clarify the provisions relating to grant of nationality to children born to non-Belizeans who have, since the birth of that child, acquired Belizean nationality; and to provide for matters connected therewith or incidental thereto.

### 2. <u>Economic Citizenship (Abolition of Rights) Bill, 2023.</u>
