12. Introduction of Bills.

1. Financial Services Commission (Amendment) Bill, 2023.

Bill for an Act to amend the Financial Services Commission Act, Act No. 8 of 2023; to specify the currency for the maintenance of capital requirements; to provide for the prior authorisation of the requested regulatory supervisor before any dissemination of information exchange; and to provide for matters connected therewith or incidental thereto.

2. Limited Liability Companies (Amendment) (No. 2) Bill, 2023.

Bill for an Act to amend the Limited Liability Companies Act, Chapter 270:01 of the Substantive Laws of Belize, Revised Edition 2020; to further facilitate compliance with the Financial Action Task Force (FATF) Recommendation 24; and to provide for matters connected therewith or incidental thereto.

3. Money Laundering and Terrorism (Prevention) (Amendment) (No. 2) Bill, 2023.

Bill for an Act to amend the Money Laundering and Terrorism (Prevention) Act, Chapter 104 of the Substantive Laws of Belize, Revised Edition 2020; to satisfy the requirements of the Financial Action Task Force Recommendations with respect to laws regarding national anti-money laundering, combatting the financing of terrorism and combatting proliferation financing; and to

provide for matters connected therewith or incidental thereto.

4. International Foundations (Amendment) Bill, 2023.

Bill for an Act to amend the International Foundations Act, Chapter 24:02 of the Substantive Laws of Belize, Revised Edition 2020; to further facilitate compliance with the Financial Action Task Force (FATF) Recommendation 24; and to provide for matters connected therewith or incidental thereto.

5. Non-Profit Organisations (Amendment) Bill, 2023.

Bill for an Act to amend the Non-Profit Organisations Act, (Act No. 14 of 2023); to provide for the Registrar to issue Certificates of Good Standing; to provide for the fees to be prescribed by regulations; and to provide for matters connected therewith or incidental thereto.

6. Belize City Port Acquisition and Settlement Deeds Bill, 2023.

Bill for an Act to facilitate the acquisition of certain shares in and movable assets and real estate from the Port of Belize Limited, by the Government of Belize, for and on behalf of the people of Belize and the implementation of the terms of deeds of settlement among the Government of Belize and Port of Belize Limited, and Waterloo Investment Holdings Limited, and the Government of Belize and Midway Investments Limited, and Belize Social Development Limited, to settle certain arbitral awards owed by the Government of Belize and outstanding litigation among the parties; and to provide for certain exemptions from the General Sales Tax Act, to facilitate the effective renovation of the Fort George Hotel; and to provide for matters connected therewith or incidental thereto.

7. General Revenue Supplementary Appropriation (2023/2024) (No. 2) Bill, 2023.

Bill for an Act to appropriate further sums of money for the use of the Public Service of Belize for the financial year ending on the thirty-first day of March, two thousand and twenty-four.

8. Education and Training (Amendment) Bill, 2023.

Bill for an Act to amend the Education and Training Act, Chapter 36:01 of the Substantive Laws of Belize, Revised Edition 2020; to increase the age of compulsory education for a child; and to provide for matters connected therewith or incidental thereto.

9. National Women’s Commission Bill, 2023.

Bill for an Act to provide for the establishment of the National Women’s Commission to advance Belize’s commitments to gender equality and equity; to promote awareness of the National Gender Policy; to recommend remedial measures, facilitate redressal of grievances and advise the Minister on all legislative and policy matters affecting women; to advocate for fulfilment of the Convention on the Elimination of All Forms of Discrimination against Women as well as other pertinent Conventions; and to provide for matters connected therewith or incidental thereto.
