## TOWNS PROPERTY EVALUATION (BELMOPAN CITY COUNCIL) (INCENTIVE PROGRAM) ORDER, 2024.

2. In this Order "senior citizen" means a person who has attained the age of sixty-five years and who is, or entitled to be, a holder of a Social Security Golden Citizen Card.

Interpretation.

3. Subject to paragraph 4, rates of discount applicable to rates of property fee payable to the Belmopan City Council in the financial year commencing on 1 April 2024 and ending on 31 March 2025, and the applicable categories are declared as follows:

Declaration of Rates of Discount.

Category	Rate of Discount
(a) Senior Citizens	50%
(b) Early Payment	15%, 10% or 5%
(c) Arrears	25%, 15% or 10%

Conditions.

- **4.** The following conditions apply to the rates of discount declared under paragraph 3–
  - (a) in relation to a person within category (a), 50% if the person resides on the property and full payment is made during the period beginning on 1 January 2024 and ending on 31 December 2024;
  - (b) in relation to a person within category (b)-
    - (i) 15% if payment is made during the period beginning on 1 January 2024 and ending on 31 January 2024;
    - (ii) 10% if payment is made during the period beginning on 1 February 2024 and ending on 29 February 2024;
    - (iii) 5% if payment is made during the period beginning on 1 March 2024 and ending on 31 March 2024;
  - (c) in relation to a person within category (c)-
    - (i) 10% if full payment of arrears is made during the period beginning on 1 January 2024 and ending on 31 March 2024, the period beginning on 1 May 2024 and ending on 15 May 2024, the period beginning on 1 June 2024 and ending on 16 June 2024, and the period beginning on 1 September 2024 and ending on 30 September 2024;
    - (ii) 20% if full payment of arrears is made during the period beginning on 26 April 2024 and ending on 28 April 2024;

(iii) 15% if full payment of arrears is made during the period beginning on 1 August 2024 and ending on 31 August 2024;
