and shall be read and construed as one with the Electricity (Tariffs, Fees and Charges) Byelaws, which are hereinafter referred to as the principal Byelaws.

2. Byelaw 14 of the principal Byelaws is amended by repealing sub-byelaws (2), (3) and (4) and replacing them with the following–

Amendment of  
Byelaw 14.

“(2) The next FTP shall commence on September 1, 2024 and terminate on June 30, 2028.

(3) The subsequent FTP shall commence on July 1, 2028 and terminate on June 30, 2032.

(4) Every subsequent FTP shall commence and terminate, respectively, on the fourth anniversary of the commencement and termination of the previous FTP.”.

3. The principal Byelaws are amended by inserting after byelaw 14, the following new byelaw–

“Prevailing tariffs, fees and regulated values.

**14A.** The prevailing tariffs, fees and regulated values as determined by the Commission in the Annual Review Proceedings Final Decision, 2023 set out in Schedule III, shall remain in effect for the Period July 1, 2024 to August 31, 2024”.

Insertion of new Schedule III.

**4.** The principal Byelaws are amended by inserting after Schedule II, the following new Schedule–
