TOWNS PROPERTY EVALUATION (BELIZE CITY COUNCIL) (PROPERTY FEE) ORDER, 2024.

2. The Property fee for **Belize City** shall be as follows-

Property fee for Belize City.

- (a) in respect of unoccupied property of a value of three hundred dollars and above, 2% of the value thereof:
- (b) in respect of unoccupied property of a value of less than three hundred dollars, the sum of one dollar;
- (c) in respect of occupied property of an annual value of thirty-five dollars and above, 10% of the annual value thereof;
- (d) in respect of occupied property of an annual value of less than thirty-five dollars, 3% of the annual value thereof,

Provided, however, that the sum of one dollar shall be the minimum rate payable in respect of a property or holding of real property.

Property fee for Caye Caulker.

- **3.** The Property fee for the village **Caye Caulker** shall be as follows-
 - (a) in respect of unoccupied property of a value of three hundred dollars and above, 1.5% of the value thereof:
 - (b) in respect of unoccupied property of a value of less than three hundred dollars, the sum of one dollar;
 - (c) in respect of occupied property of an annual value of thirty-five dollars and above, 2.5% of the annual value thereof;
 - (d) in respect of occupied property of an annual value of less than thirty-five dollars, 3% of the annual value thereof,

Provided, however, that the sum of one dollar shall be the minimum rate payable in respect of a property or holding of real property.

Property fee for St. Georges Caye.

- **4.** The Property fee for **St. George's Caye** shall be as follows-
 - (a) in respect of unoccupied property of a value of three hundred dollars and above, 1% of the value thereof;
 - (b) in respect of unoccupied property of a value of less than three hundred dollars, the sum of one dollar;

- (c) in respect of occupied property of an annual value of thirty-five dollars and above, 6% of the annual value thereof;
- (d) in respect of occupied property of an annual value of less than thirty-five dollars, 3% of the annual value thereof.

Provided, however, that the sum of one dollar shall be the minimum rate payable in respect of a property or holding of real property.

5. The rates specified in paragraphs 2, 3 and 4 are applicable for the financial year beginning on the 1st of April 2025.
