BYELAWS made by the Public Utilities Commission, in consultation with licensees and with the approval of the Minister responsible for water and sewerage, in the exercise of the powers conferred upon it by section 87 of the Water Industry Act, Chapter 222 of the Substantive Laws of Belize, Revised Edition 2020, and all other powers thereunto to it enabling.

and shall be read and construed as one with the Water Industry (Tariffs) Byelaws, which are hereinafter referred to as the principal Byelaws.

2. Byelaw 13 of the principal Byelaws is amended by deleting sub- byelaws (3) and (4) and substituting them with the following-

Amendment of
Byelaw 13.

“(3) The next Full Tariff Period shall commence on April 1, 2026 and terminate on March 31, 2031.

(4) Subsequent Full Tariff Periods shall commence and terminate, respectively, on the fifth anniversary of the commencement and termination of the previous Full Tariff Period.

(5) In determining the tariffs for any Full Tariff Period, the PUC shall take into account notified items and the performance standards of the licensee.”

3. The principal Byelaws are amended by inserting after byelaw 13, the following new byelaw–

“13A. The prevailing tariffs, fees and charges as determined by the Commission in the Annual Review Proceedings Final Decision, 2022, set out in Schedule IV, shall remain in effect for the Period April 1, 2025 to March 31, 2026.”
