AN ACT to amend the Customs and Excise Duties Act, Chapter 48 of the Laws of Belize, Revised Edition 2020, to implement the eleventh phase of reduction of duties in accordance with the CARIFORUM-EU Economic Partnership Agreement; to implement the eleventh phase of reduction of duties in accordance with the CARIFORUM-UK Economic Partnership Agreement; to implement the second and third phase of reduction of duties in accordance with the Belize and the Republic of China (Taiwan) Economic Cooperation Agreement; and to provide for matters connected therewith or incidental thereto.

BE IT ENACTED, by and with the advice and consent of the House of Representatives and Senate of Belize and by the authority of the same, as follows:

- 1.** This Act may be cited as the

CUSTOMS AND EXCISE DUTIES (AMENDMENT) BILL, 2025,

and shall be read and construed as one with the Customs and Excise Duties Act which, as amended, is hereinafter referred to as the principal Act.
