1. **Customs and Excise Duties (Amendment) (No.2) Bill, 2025.**

Bill for an Act to amend the Customs and Excise Duties Act, Chapter 48 of the Substantive Laws of Belize, Revised Edition 2020, to vary the rate of duty on soups and broths in solid or powder form including Ramen noodles and other related items in the Customs Tariff and Trade Classification; and to provide for matters connected therewith or incidental thereto.

2. **Money Laundering and Terrorism (Prevention) (Amendment) Bill, 2025.**

Bill for an Act to amend the Money Laundering and Terrorism (Prevention) Act, Chapter 104 of the Substantive Laws of Belize; to satisfy the requirements of the Financial Action Task Force Recommendation with respect to digital assets and digital asset service providers; and to provide for matters connected therewith or incidental thereto.

AND WHEREAS, Brand Manual Guidelines have been developed to establish a clear and consistent framework for the use of the National Assembly's logo, typeface, colours, and brand identity across all communications, ensuring integrity, professionalism, credibility and national representation;

AND WHEREAS, the Cabinet Secretary, His Excellency Stuart Leslie, has advised the Speaker of the House of Representatives and Chair of the National Assembly Staff Committee, Honourable Valerie Woods, of the Honourable Prime Minister's and Cabinet's approval of the new logo and their support for its formal adoption;

NOW, THEREFORE, BE IT RESOLVED that this Honourable House adopts the logo annexed to this Motion to be designated as the official Parliamentary Logo of the National Assembly of Belize;

AND BE IT FURTHER RESOLVED that the Clerk of the National Assembly shall be responsible for the management, safeguarding and authorised use of the Parliamentary Logo.
