**SUPPLIES CONTROL (PRICES) (AMENDMENT)  
(NO. 22) (REGULATIONS, 2025,**

and shall be read and construed as one with the Supplies Control (Prices) Regulations, which, as amended, are hereinafter referred to as the principal Regulations.

2. The principal Regulations are amended in Part D of the First Schedule by repealing the retail prices for Liquefied Petroleum Gas, and substituting the following, effective June 30, 2025-
