ORDER made by the Minister responsible for Local Government in exercise of the powers conferred upon him by section 18A(5) of the Towns Property Evaluation Act, Chapter 65 of the Substantive Laws of Belize, Revised Edition 2020, and all other powers thereunto him enabling.

TOWNS PROPERTY EVALUATION (COROZAL TOWN COUNCIL) (INCENTIVE PROGRAM) ORDER, 2026.

2. In this Order “senior citizen” means a person who has attained the age of sixty-five years and who is, or entitled to be, a holder of a Social Security Golden Citizen Card.

Interpretation.

3. Subject to paragraph 4, rates of discount applicable to rates of property fee payable to the Corozal Town Council in the financial year commencing on 1 April 2026 and ending on 31 March 2027, and the applicable categories are declared as follows:

Declaration of Rates of Discount.

Category	Rate of Discount
(a) Senior Citizens	50%
(b) Early Payment	15%, 10% or 5%
(c) Arrears	30%, 25%, 20% or 15%

Conditions.

4. The following conditions apply to the rates of discount declared under paragraph 3–
- (a) in relation to a person within category (a), 50% if the person resides on the property and full payment is made during the financial year commencing on 1 April 2026 and ending on 31 March 2027;
 - (b) in relation to a person within category (b)–
 - (i) 15% if payment is made during the month of January 2026;
 - (ii) 10% if payment is made during the month of February 2026;
 - (iii) 5% if payment is made during the month of March 2026;
 - (c) in relation to a person within category (c)–
 - (i) 25% if full payment of arrears is made during the period beginning on 3 August 2026 and ending on 14 August 2026;
 - (ii) 15% if full payment of arrears is made during the period beginning on 17 August 2026 and ending on 31 August 2026;
 - (iii) 30% if payment of arrears is made during the period–
 - (A) beginning 11 May 2026 and ending on 22 May 2026;
 - (B) beginning 8 June 2026 and ending on 19 June 2026;

- (iv) 20% if payment of arrears is made during the period beginning on 22 June 2026 and ending on 30 June 2026;
- (v) 15% if payment of arrears is made during the period beginning on 14 September 2026 and ending on 25 September 2026;
